- Appropriate action agreed with Landlord and actioned with Tenant
- All day-to-day Tenant queries and issues managed
 - All incidents reported in writing to Landlord within 24-hours
- All general maintenance and repairs managed and facilitated
 - All requirements and estimates provided in writing to Landlord for approval prior to commencement of works
 - All our Service Suppliers have been vetted and we hold copies of their appreciate accreditations and qualifications (Gas Safe, NIC EIC, etc) on file
- All emergency calls managed
 - Office open seven days a week to facilitate immediate response
 - Landlord approval on appropriate action always sought

 - Follow-up report and associated costs provided to Landlord within 24-hours of incident
